

## TERMS OF SERVICE/TERMS AND CONDITIONS AS OF 10/5/19

### FOR ADVISORS:

We welcome all advisors who pass our due diligence to subscribe and be a part of the MyPerfectFinancialAdvisor community. In order to qualify, a person and their firm must be currently licensed and/or registered with one of the following regulatory bodies: FINRA, SEC, or their state. Each person wishing to subscribe must have a clean U4 and/or ADV, meaning there cannot be even one disclosure, even if that disclosure was a false accusation. If an advisor registers and pays to subscribe and fails to check their U4 and/or ADV prior and indeed there is a public disclosure, a refund of their subscription fee less \$150 will be processed within five business days.
